## **ORDINANCE NO. 436**

## AN ORDINANCE TO AMEND ORDINANCE NO. 435 ORDINANCE REGULATING THE SALE AND CONSUMPTION OF LIGHT WINES AND BEER WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF LUCEDALE

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF LUCEDALE, MISSISSIPPI:

**SECTION 1:** <u>PURPOSE</u>. The City of Lucedale passed an Ordinance Regulating the Sale and Consumption of Light Wines and Beer Within the Corporate Boundaries of the City of Lucedale and the Board of Aldermen is desirous of amending said Ordinance.

SECTION 4: That Section 12 subsection (12) of STANDARDS FOR LICENSURE; INVESTIGATING COMMITTEE; REASONS FOR REFUSAL. All applicants for a Retailer and Beer and Light Wine Privilege License must possess a valid Mississippi Beer License and valid United States ATF License at the time said privilege license is issued.

THAT SECTION 12 SUBSECTION 12 OF STANDARDS FOR LICENSURE; INVESTIGATING COMMITTEE; REASONS FOR REFUSAL IS HEREBY AMENDED AS FOLLOWS:

SECTION 5: STANDARDS FOR LICENSURE; INVESTIGATING COMMITTEE;
REASONS FOR REFUSAL. All applicants for a Retailer and Beer and Light Wine
Privilege License must possess a valid Mississippi Beer License and a Triple III
background Check at the time said privilege license is issued. A Triple III
background check may be obtained at a local law enforcement agency.

**SECTION 6:** PUBLICATION AND EFFECTIVE DATE. This ordinance shall be published in the George County Times and become effective and in force thirty (30) days after its passage.
